By downloading and installing this software on his computer, the user agrees with the terms and conditions outlined in the present License Agreement.

In the event the user is not agreeing with any of the terms and conditions outlined herein, he shall uninstall this software from his computer.

1. ALPHA AND BETA STATUS OR PRE-RELEASES

The present License Agreement also formally applies to this software in “alpha” or “beta” or “pre-release” or “work in progress (WIP)” status, despite its usage for any commercial or otherwise serious/important projects is highly discouraged and should be limited to evaluation / practicing.

3. use the resulting plugins personally and/or distribute them, either in form of free or commercial software, as long as they are distributed and/or sold exclusively under the user's name and/or brand.

Any other usage not listed here, including commercial exploitation of this software in books, magazines, scientific publications or any other media is forbidden, unless expressly authorized by Elena Design under written permission.
